1	For the specific provisions of the double diploma Master's program Applied Physics / Science Education and Communication, reference is made to Appendix 7. However, these provisions are missing in the current PER. Also reference is made to the Master's program Science Education and Communication, while the name of that program has been changed to Science Education since September 1, 2023.	The specific provisions of the double diploma Master's program Applied Physics / Science Education have been added to a new appendix 8. The reference to appendix 7 has been replaced by a reference to appendix 8. Science Education and Communication has been renamed Science Education where applicable.
3	The homologation program for students who started their pre-Master's program before September 1, 2024 is missing.	The missing homologation program has been added and is identical to the homologation program mentioned in the PER MSc AP 2023-2024.
	The number of credits is missing from the condition that students must successfully complete an additional elective. From the context of the PER it is clear that 5 credits of electives is meant, but this should be stated explicitly to avoid confusion.	The number of credits have been specified and the wording has been changes so that also two electives of 2.5 credits each can be chosen.
7	Wrong terminology for double diploma program.	Double degree replaced by double diploma.
	As of September 1, 2024, the combined internship AP-NF 3APNF15 has been discontinued and students will have to choose between the AP external internship 3MA15 or the NF external internship 3NFS15. However, the combined internship AP-NF 3APNF15 is still mentioned in the double diploma Master's program AP/NF.	The combined internship AP-NF 3APNF15 has been replaced by 'External internship'. The current PER already states that students will have to choose between the AP external internship 3MA15 or the NF external internship 3NFS15.
	A transitional arrangement for students who have started the combined internship AP-NF 3APNF15 before September 1, 2024 is missing.	A transitional arrangement has been added for students who have started the combined internship AP-NF 3APNF15 before September 1, 2024.
	Reference to 'internship' is not in accordance with the rest of the PER, which refers to 'external internship'.	'internship' has been replaced by 'external internship' where applicable.
	For the procedure concerning the assessment of the external internship and the graduation project reference is made to the Examination Regulations of the Examination Committee of the Department of Applied Physics and Science Education 2022-2023. However, the Examination Committee of the department Applied Physics and Science Education does not exist and the academic year is outdated.	For the procedure concerning the assessment of the external internship and the graduation project, reference is made to the Examination Regulations of the Examination Committee 2024-2025 of the relevant degree programs.
8	The specific provisions of the double diploma Master's program Applied Physics / Science Education and Communication are missing.	The specific provisions of the double diploma Master's program Applied Physics / Science Education and Communication have added and are identical to those in the PER MSc AP 2023-2024 apart from the fact that Science Education and Communication has been renamed Science Education where applicable.
