- 6. Knowledge of the literature.

- 1. Global structure (balance of intro-analysis-conclusions).
- 2. Quality of slides (right amount of information, relevance of the information for the audience, figures).
- 3. Balanced presentation, audibility, contact with the audience, finish in time.
- 4. Answering questions.

Defense

- 1. Understanding the question.
- 2. Quality and relevance of the answers.
- 3. Defend opinions, admit mistakes.

Execution of the project

- 1. Originality and independence.
- 2. Transition from "being guided" to "guiding".
- 3. Maintaining the project's main goal if possible, adjusting the course if necessary.
