

How to make an MN poster

Before making your poster

Before you start to make your poster, first quickly walk through the corridor. When you arrive at the end, think of posters that caught your attention. Then think of why these posters caught your attention. Most likely this will be posters with many colorful pictures and not too much text. Make sure your poster will be noticeable!

Also, try to explain to someone in ten minutes about your work using pen and paper. What pictures did you draw? What results did you present? Those pictures should become the figures on your poster. Using only those pictures you should be able to explain your work and your results. A rule of thumb is to have four figures.

Options of the stylefile

This stylefile has two kinds of options. The first kind of options has to do with the papersize. Specify either `a4` (which is used for the website) or `alplus` (which is used for plotting). The second kind of options is related to the color of the titleframe, which default is `red`, but can also be `orange`, `green`, `cyan`, or `blue`.

So, in order to obtain a large size poster with tick marks, with a cyan titleframe, start your document with

```
\documentclass[a4,cyan]{mnposter}.
```

Color usage

Restrict the colors in your figures to the TU/e main colors:

PMS Process Cyan RGB 0,162,222

PMS Warm Red RGB 247,49,49

PMS 206 RGB 214,0,74

PMS 226 RGB 214,0,123

PMS 253 RGB 173,32,173

PMS 300 RGB 0,102,204

PMS 2748 RGB 16,16,115

and the TU/e support colors:

PMS 137 RGB 255,154,0

PMS Yellow 012 RGB 255,221,0

PMS 396 RGB 206,223,0

PMS Green RGB 0,172,130

PMS 3135 RGB 0,146,181

PMS 375 RGB 132,210,0

Logos of partners/sponsors

Logos of partners/sponsors can be added to the MN logo on the top of the poster. For this the macro `\otherlogos` has been provided. For an example of the usage, see the \LaTeX source of this document. For logos of partners/sponsors, a box of width 52mm and height 18mm is available (formatting of a TU/e scientific poster is defined on A3).

Keep in mind that according to the TU/e corporate identity (TU/e huisstijl), at most three logos of partners/sponsors can be used, where the (optical) size of these logos should be less than that of the TU/e logo.

Other remarks

Most of the standard \LaTeX macros should be available. As an examples, figures can be included in the standard way. You can refer

to this figure as Figure 1. In a similar way also tables can be entered. Furthermore, equations can be entered in the standard way:

$$\dot{x}(t) = Ax(t) + Bu(t) \quad x(0) = x_0 \quad (1a)$$

$$y(t) = Cx(t) + Du(t) \quad (1b)$$

and you can refer to (1) or (1b).

If desired, one can even add references, such as [1].

Final remarks/suggestions for improvement

Keep in mind that stylefiles should not be edited, so if you feel a need for modifying the stylefile either a new version of the stylefile should be made available via the website, or you should solve your problem differently.
